8. **Police Department Report.** McElroy gave the monthly report covering the training for officers. Officer Rittenhouse and Lieutenant Reese spoke to the GSA (gay, straight alliance) group at the Evansville High School Friday, April 26th. Officer Wickstrum, Chief McElroy, Lieutenant Reese, Jen Braun (BASE) and the Evansville Postmaster presented "Senior Scams" to a group of seniors on Tuesday, April 23rd at Creekside. Our "Drug Take Back: day Saturday, April 27th took in approximately 82 pounds of drugs and medications from this day and the previous 6 months. The radar trailer is out and about throughout the City. EPD staff continues to monitor and record sound results at the Night Owl. So far none of the measurements have been excessive or even close to excessive. EPD has been recording cars parked on Franklin Street. Brad F. at Nelson Young Lumber Company confirmed with Chief McElroy on April 29th that he wants to be a good neighbor and agreed to allow Night Owl overflow parking at Nelson Young Lumber as needed. We continue to work with the school district and the 911 center on project "Direct Connect." Calls for April were 1132 in 2019; and 1038 in 2018. Number of license plate transactions for April 2019 were 35. The Police Commission is meeting at 5pm on May 31st at the Police Department.
