UPDATE (#10):

Rock County Sheriff's Office continues to work with other local, state, and federal law enforcement agencies to locate and apprehend Joseph A. Jakubowski (M/W, DOB: 07/21/84, 5'10", 200 lbs., green eyes and brown hair). At this time, approximately 700 tips have been received, and investigators are currently pursuing about 130 tips.

The Wisconsin Lottery, a valuable partner of the Wisconsin Department of Justice in the dissemination of missing persons alerts, has published an alert to all of the lottery terminals in the state. The terminals can be found in gas stations, convenience stores, grocery stores, and other Lottery retailers. The published alert message is available for the store clerks and other employees to see. The alert message provided a photo of Jakubowski and instructions to notify law enforcement by calling 911. This technology is used with AMBER and Silver Alerts in Wisconsin.

In News Release – Update #8, we provided a tattoo "BOY" (labeled "BOS") photo from Jakubowski's right upper arm. Investigators have since learned that Jakubowski covered this tattoo with a newer tattoo. Accordingly, the "BOY" tattoo photo is no longer applicable.

In an effort to improve accessibility, previously released documents related to the Jakubowski case are now available directly from the Rock County Sheriff's Office website at <http://www.co.rock.wi.us/sheriff-jakubowski>. These files include the Post Office Video where Jakubowski mails his manifesto and the Criminal Complaint against Jakubowski.
