







Your Water Usage




Important Information in understanding your bill

The City works to keep billing cycles of 30 days consistent, however calls for outages or route days falling on holidays/weekends may alter when staff are able to read your meter. If your cycle is shortened or lengthened for this reason, it can significantly alter your monthly bill same as changes in temperature.

Billing cycles may also start 2 months before you receive the bill depending on your route. Your March bill may have the colder months of December and January use within your bill.

The whole bill is not just electric but also includes water and sewer. If you see a significant increase for reasons not described above, **also** check for leaking toilets, water softeners, and outside spigots. If you have such a leak the Utility may be able to credit a portion of the sewer charge.

DUE DATE

Bills are issued on the 8th day of every month. Late charges shall be applied no sooner than 20 days after the date of issuance of the bill.

POWER COST ADJUSTMENT

This adjustment reflects the variance in the cost of purchased power from the amount included for these costs in our basic electric rate.

METER READING

Meters are read monthly. If the utility is unable to read the meter, usage will be estimated based on historical usage and will be identified with an "ER" following the applicable usage as listed in the Current Meter Information section above. If you have questions concerning estimated reads, please contact our office.
